ABSTRACT

This study aims to analyze and assess the performance of principals who have implemented school-based management (SBM). An alternative management system tool to measure the work efficiency of the institution in measuring the performance of Al Lathif Islamic School in the city of Bandung using the Balanced scorecard model. A balanced scorecard is a management tool that translates the vision, mission, and organizational strategy of the Al lathif Islamic School into a set of four perspectives, namely the financial, customer, and internal business processes, as well as learning and growth perspectives. This study uses a quantitative approach with descriptive analysis. Primary data in the form of a questionnaire is used to measure the performance of the financial perspective and the perspective of learning and growth, while the measurement of the performance of the financial perspective and internal business process perspective uses secondary data. Sources of data were obtained from Educators, Education Personnel, Students, and Parents, EDS Documents, The Education Unit Accreditation Instrument (2021), Principal's Annual Work Assessment, School Financial Accountability Reports, and School Alumni Documents. The results showed that the performance of Al Lathif Islamic International School was in the very good category. Based on the financial perspective, obtaining good performance, namely meeting the economic requirements, effectiveness, and efficiency. Based on the perspective of the customer get a very good value by applying five dimensions (tangibility, reliability, responsiveness, assurance, empathy). Based on the internal business process perspective, the measurement results can be shown from the innovation aspect, operation aspect, and alumni service that has shown very good value results. Based on the learning and growth perspective, four indicators, namely the range of employee satisfaction, training, employee loyalty, and employee performance productivity are in the very good category

Related with culture quality, Al Lathif Islamic School has been crowned as 1st (one) winner at the National School Level event and International which has culture quality best. However the problem is one challenge biggest based on results study implementation of SPMP in units institution education, up to moment this still face various type problem which include : (1) implementation of guarantee and upgrade quality education still limited to monitoring component quality in units education; (2) mapping quality still in shapes data collection achievement quality education that has not integrated from various management education ; (3) act carry on results mapping quality education that has not utilized for necessity enhancement quality sustainable ; (4) implementation evaluation Evaluation Self Schools (EDS) and their assessment instruments not yet understood by intact as needs school; (5) not yet socialize it National Education Standards as reference quality education. (Suwarni, Moerdiono, Prihatining, & Sangadji, 2020) and (Prayoga, Irawan, & Rusdiana, 2020).

Referring to the problem that, according to Ministry of National Education (2011: 12) contained in "Analytical Study Accreditation School " turns out to be there is a number of weakness system evaluation with pattern accreditation , namely : 1) Length plot work in accreditation ; 2) Implementation manual tasks ; 3) Complexity work ; 4) Repetition work ; 5) No there is integration with service other and; 6) risk lost document. (Sitorus, 2016).

So as with stipulation of PP No. 19 of 2005 concerning National Education Standards (SNP), schools expected use evaluation performance with instrument Evaluation Self School (EDS). EDS is evaluation self school in SNP container. Through school EDS could know the correct data about 8 SNP instruments that provide description about implementation of the educational process in schools will but no capable give description performance school by by thorough. Besides that is also the implementation of EDS and instruments the appraisal not yet by intact as needs school. Because it happened shift paradigm System Guarantor Quality of Education to be focused on to inspection. (Pambudi, 2018)

Essence System Guarantee School Internal Quality is effort in grow culture quality, define and own standard, implement standard, implementation standard and improve standard by sustainable (Continuous Quality Improvement) by level Education Unit.

Cycle guarantee this internal quality becomes very important in institutions that have high commitment to quality. Especially faced with tough competition as well as change very fast technology and information. This thing demand existence System Guarantor Quality for ensure quality service right education since beginning and forever right first and every time as well without defect Zero defect, in order to keep it trusted by stakeholders and the community, that Al Lathif Islamic School is a school something the agency that bears trust Constitution in educate nation. (Jahari, 2018) Problems other is figure figure head school the case of SMKN 1 Bukit Kemuning, (2021) as a stakeholder does not fast, no firm, unfair and not realistic, for handle procedure handler complaint as one constant standard must repaired which has been set every year through implementation, monitoring, evaluation and feedback carried out by sustainable. "The main purpose of quality teaching initiative is to help the institution contemplate a journey of constant improvement and regular evaluation for feedback." (IMHE, 2022, p.37). Whereas many hopes and needs from parents, students, teachers and the community want institution create products and services that are produce offer product or results graduate of quality high, so could build trust and loyalty with customer. Standards and procedures set by parents, students and the community could produce a guarantee program quality help prevent disabled product.

"Importance of quality assurance, quality assurance helps a company create products and services that meet the needs, expectations and requirements of customers. It yields high-quality product offerings that build trust and loyalty with customers. The standards and procedures defined by a quality assurance program help prevent product defects before they arise" (Gillis, 2020)

Case the problem is in the unit education above with implemented system government it turns out not yet capable To do measurement that performance could see aspect the perception of parents and then existing in unit education, for example (1) student/parent satisfaction during the school measurement satisfaction customers / guardians of students and students, (2) The satisfaction of teachers and employees as well as other educational stakeholders has not become a priority for measuring performance, teacher and employee satisfaction and education stakeholders not yet Becomes priority measurement performance. Condition this make school no knowing by holistic about performance school. Whereas School must could reach performance by comprehensive. (3) student exit survey, satisfaction for alumni (4) special survey for capturing special events related to the quality of teaching and learning, which is conducted tentatively. Survey special for catch incident related special with quality study teaching, doing by tentative.

At the Al Lathif Islamic School Bandung, it refers to studies results preliminary still beginning recommend amount problem in implementation quality at the level unit education as following including (1) policies unfinished quality in accordance with steps guarantor quality externally and internally comprehensive, for example policy document quality still different with standard accreditation, then use Evaluation A different self with those issued by BSNP. (2) Guarantee agency internal quality that is centered to on still considered not yet effective for monitor achievement quality at grass root level. As opinion opinion (Wilborn et al., 1994):

"Quality Assurance and Quality Improvement are both essential elements of comprehensive quality management, and quality assurance embraces quality planning and quality control, with so how is the implementation of the system quality assurance at the education unit level itself will greatly depend on the quality of the planning and quality

control itself where both apply to each element factors that affect operational effectiveness school internal quality assurance as presented in the first consideration section.

(Wilborn et al., 1994) argues that quality assurance includes quality designs and quality control, then effectiveness is also affected with the quality assurance tools used, or in other words in implementation called with system guarantor internal quality of the school

One of the tools measurement evaluation comprehensive work good covers analysis internal and external factors from the Al lathif Islamic School institution is with with use Balanced Scorecard (BSC) method. BSC is one of the method used for measure performance management, method this start introduced at the beginning 1990 in the United States by Robert S. Kaplan and David P. Norton via something research about " measurement " performance in future organization".

in terms of etymologically, the Balanced Scorecard is consist from two syllables, balanced words and scorecards. The word balanced, balanced means balanced. In context this, concept balance in the Balanced Scorecard related to three areas, namely: (a) Balance Among indicator success financial and non- financial. (b) Balance Among internal and external constituents from organization; Stakeholder interests and customers represent constituent external in the Balanced Scorecard, while employees and internal processes represent internal constituents. (c) Balance Among indicator performance lag and leads. Indicator lagg by general represent past performance. Temporary that lead indicator is trigger leading performances in lag indicators, (Dally, Corvazier, Bredoux, Bobe, & Enouf, 2010).

BSC defined by short as framework work translating management organizational mission and strategy into the set size performance that provides framework work for measurement and system strategic management (Kaplan & Norton, 1996). BSC has four perspective, that is finance, customer, business process in enterprise, and the learning and growth process. (Arabaci, 2017) in His research also reveals the Balanced Scorecard method can applied in education. evaluation performance school with Balanced Scorecard approach is expected could resolve various weakness long performance this done at the institution education.

Many programs in the world of education have been implemented by the government, and Al Lathif Islamic School is expected could enhancement quality education at the time crisis, because poor management flexible and inclined decreased. This thing suspected close with problem management (Mulyasa, 2014). Various effort has conducted for increase quality education at Al lathif Islamic School, including increasing curriculum independence, procurement teaching materials, improvement competence of teachers and staff education, improvement management education, effort enhancement management education through approach empowerment school at Al lathif Islamic School in skeleton manage institution education in the era of autonomy regions, an empowerment program appears school through Management Based on School (MBS) is appropriate with Constitution Number 20 of 2003 concerning Article 51 of the National Education System, which states that management unit education child age early education basic education, and SBM education is one of the strategies set by Indonesia as a standard in develop superiority management school. Affirmation this poured in the National Education Act Number 20 of 2003 concerning National Education System in article 51 paragraph 1 that management unit education medium held based on standard minimal service with principle managementbased school. Implemented MBS moment this expected capable for increase quality education that is also oriented towards the implementation process education, no only oriented to the long - term input this many occurs in schools in Indonesia. MBS aims for increase all performance schools (effectiveness, quality / quality, efficiency, innovation, relevance, and equity as well as access education). By simple held based on standard minimal service with principle Management Based on school. While the empowerment model MBS implementation with the BSC approach according to (Dally et al., 2010) mentions that the second Integration draft the explain that management strategic that includes observation environment external and internally, strategy formulation, strategy implementation, evaluation and control, is used for anticipate happening change both internal and external, so that Thing the chance for To do empowerment implementation Management Based on school. Whereas Balanced Scorecard approach with four his perspective which includes customer; learning and growth; internal business processes; finance; could used in system control strategic, so occur the part that doesn't inseparable from cycle management strategic.

(David, Cristea, & Hofmann, 2018) and (Rangkuti, 2015) using integration SWOT analysis, BSC is able recommend some strategies, such as To do SWOT analysis, compiling strategy formulation, strategy theme and strategy map, compiling strategic initiatives and KPIs, providing weights and scores, cascading SWOT and Balanced Scorecard, compiling program plans work and budgeting, monitoring and evaluation, improvement performance finance through collection and savings, rejuvenation facilities and infrastructure, and improvement compensation for retention employees, and planning repeat source power man for every team building or appropriate departments and functions with competence and qualifications.

(Dally et al., 2010) and (Wijaya, 2014) state that the BSC is integrated very well with Management Based on school. Internalization of BSC in Management Based on School more good compared measurement based on MBS alone (Fajrin, 2018). Because focus to mission and vision, school could more notice current costs and benefits apply management performance (Chatterji & Patro, 2014) then need innovation and management management by professional in accordance with demands environment, so no left by the customer.

Besides that, the government has also Secrete policy System Guarantee Quality of Education (SPMP) contained in in Permendiknas Number 63 of 2009 concerning Guarantee Education Quality. As listed in Law No. 20 of 2003 concerning system education national Article 50 (1) " Management unit education child age early education basic and education medium held based on standard minimal service with principle management based school /madrasah" MBS is a paradigm new education that provides autonomy area at level school with mean that school free manage source resources and sources of funds with allocate it in accordance with priority needs school.

The choice of a balanced scorecard, as approach in study this because at Al lathif Islamic School because with a number of reason among others: (a) from a number of study show that BSC is worthy used in monitoring and evaluation performance institution education but also very good internally and external and satisfactory; (b) BCS can become a tool in MBS implementation is factor knowledge and ability device management still school weak about composing planning strategic institutions and their descriptions in more planning operational so that needed; (Yüksel & Coskun, 2013); (3) Usage Balanced Scorecard method in measurement performance organization allow implementation measurement performance organization from aspect finance, customer, business process internal as well as learning and growth based on achievements the target that has been set by the organization with refers to the goals, vision and mission that have been proclaimed. The Balanced Scorecard approach can take into account entity as comprehensive function with link vision, mission, institutional strategy, and measurement comprehensive and progressive performance. Purpose and size operational the translated in four perspective that is that is perspective financial, customer, internal business processes, and learning and growth.

Al Lathif Islamic School as organization, have vision, mission and goals to be achieved. Achievement vision, mission and goals organization is largely determined by management to source whole power and holder interests in Al lathif Islamic School. How far is the vision, mission, and goals? organization, assessment, school so that quality education and management school Keep going increase and give satisfaction to whole customers and stakeholders so that quality education and management institution Al lathif Islamic International School education continues increase and give satisfaction to whole its stakeholders.

Based on background behind that and relate with evidence justification to a number of problem special to system guarantor the internal quality of the school, plus again with various research data results beginning and theory before, then need existence Head Performance Analysis Al Lathif Islamic School Dalam Balanced Scorecard Perspective. Goal is for get description performance comprehensive performance compared with measurement performance, which has been conducted with other approaches ever done.

Data collection is done researcher with method: a Questionnaire. Method Questionnaire is technique data collection carried out with method give set question written to respondent for answered or statement closed (which has been determined the answer). (Sugiyono, 2017). Method this used for get relevant primary data with perspective learning and growth, and perspective customer. b. Interview, Type selected

interview in study this is Interview no structured. Interview no structured is free interview where researcher no use guidelines interviews that have arranged by systematic and complete for collection the data. (Sugiyono, 2017). Interview done in skeleton deepening to results analysis measurement performance for determine Balanced Corecard SWOT analysis. Involved resource persons cover party Director of Al Lathif Islamic School. Head School , Head of Bureau II Division Curriculum and Student Affairs , Curriculum staff , homeroom teacher, teacher as internal sample while Students and Parents , alumni data, as an external sample.

Documentation.

Method this used for obtain related secondary data with perspective financial and internal business process perspective in the form of search document belonging to Al Lathif Islamic School Bandung City in 2021, such as document profile school, result evaluation self school (Evadir), results supervision learning, report realization finance as well as other data, Accreditation Instrument Education Unit (IASP) 2021 used for Accreditation is also Assessment work Annual Head School (PKKS) in 2022 used as reference from preparation of KPI or Key Performance Indicators of Al Lathif Islamic School. IASP 2021, EVADIR and PKKS 2022 point focus on quality graduation, learning process, quality schools, teachers and management school. The data processing and analysis process includes data reduction, data display and retrieval taking conclusion. Data processing and analysis is carried out for get KPIs as well KPI weight for each from KPI AL Lathif Islamic School, as well as get score priority of KPIs.

RESULTS AND DISCUSSION

A. Measurement of Al Lathif Islamic School Bandung with Approach Balanced Scorecard

Based on observation could is known that the head of Al lathif Islamic School has qualification education Strata 2 (S2) but now currently continue Strata 3 (S3) Study Program Doctor Educational Sciences while composition power educators and education of Al lathif Islamic School based on The level of education at the SI level is 35, the S2 level is 10, while the S3 level is 6 people. Educators and staff education this originated from graduate of at home and abroad. Exposure analysis results study for measure Al Lathif Islamic School performance with use BSC approach begins from performance perspective finance, internal business process perspective, perspective customer, perspective learning and growth, and finally displayed results whole measurement four BSC perspective so that arranged something analysis Al lathif Islamic School performance based on BSC perspective.

1. Perspective Performance Analysis Finance Al lathif Islamic School Bandung

Measurement to performance perspective finance at *AL Lathif Islamic School* with see performance from perspective provider source of funds and achievement of financial targets as planned by the school. Al Lathif Islamic School is a organization school. Measurement performance his finances conducted with use size performance public. In entity business perspective finance could be measured with refers to income operations, income clean and so on. (Hoque, 2003) It is could understood, because source income school is from APBN funds, BOS (Aid) Operational Students) designed based on Plan Activity RAKS School and Report Realization Budget and Budget School year 2020/2021. Presentation Report Realization Budget conducted with method juxtapose information realization and budget agency government) PP No. 24 of 2005, p. 2). In addition

to funds from BOS, there are also funds from donation monthly students, the participant 's Education Contribution Fund (DSP) educate new, as well as selffunding or other sources as business funds independent school. As for the allocation of donation funds monthly student among them for the honorarium education, because allocation from BOS funds no fulfilled. Allowance other like allowance day feast, wages overtime, bonuses and journey service. Whereas needs means infrastructure funds come from from foundation. Implementation activity School both PHBN and PHBS as well as activities that have been programmed During one year for student, then charged to students and this based on results POMG and committee deliberation school. Allathif Islamic School in Fulfill performance finance based on *Value for Money. Value for Money.* is a Suite indicator whose elements is unity from *inputs*, *outputs* and *outcomes. Value for Money* applied at Al Lathif Islamic School as a standard for Fulfill principle economical, efficiency and effectiveness the event together.

Based on analysis performance of Al Lathif Islamic School in Bandung. Based on draft *value for money* (Mahsun, 2009) and mahmudi (2010) as following: a. Economic rate be measured with method compare realization budget shopping with budget targets shopping.

CONCLUSION

It is obvious from the foregoing discussion that while constitutionalism has assumed new prominence in West Africa in the last two decades, compliance with the constitutions and the law is often vulnerable and minimalist, rendering ineffective the basic constitution-guaranteed rights and freedoms. Under the circumstances, a lot more needs to be done both at the level of ECOWAS and within member states in translating the rhetoric on democratic governance and stability into practice.

At the sub-regional level, the following should be made priority:

ECOWAS should design ways to mitigate elements that lead to political breakdown and coups. Issues which should be of regional concern include clear breaches of the constitution by a state's own government, rigged or suspect elections, clear and significant breaches of human rights including exclusionary practices, high and continuing level of corruption.

ECOWAS should monitor the constitutions of member states to ensure that they abide by regional standards with particular reference to term limits. To this end, the Secretariat is to prepare annual reports on transparency and good governance in each of its member states.

The ECOWAS Parliament as presently has practically no oversight role and lacks powers to enforce its decisions and to elicit compliance from member states. To be effective, therefore, the ECOWAS Parliament should be empowered to censure erring governments and to have the power to order international investigation into reported and suspected cases of human rights abuses.

Within each member states, the following should be prioritized:

The government needs to accept a tacit level of supervision of their domestic politics by other states within the region, permitting regional mediation between governments and opposition forces, a measure of external pressure where this is needed to induce compliance.

There is also an urgent need for social dialogue among stakeholders in the political process to ensure the minimizing of bitterness, avoiding the stigmatization of others, and broad consensus on the rules of the game. The introduction of inter-Party Advisory Committee which has worked so well in Ghana is recommended. To ensure some level playing ground, it is essential that there is some form of state funding of political parties.

Civil societies should be empowered not only as a means of expanding political participation but also to promote popular vigilance and enhance the watchdog role of civic actors and citizens groups. The massive and vigorous manner in which the National Civil Coalition against Third Term Agenda in Nigeria pressured the national legislature to reject the amendment to lift the two-term is worth emulating.

In conclusion, the constraints that persist in the form of institutional resources and of socio-cultural practices need to be addressed, if the vision of a truly representative and participative system is to be fully translated into reality. In particular, West African leaders should be constantly reminded that power entails responsibilities to protect, care for and be accountable, to the people. What is required within the sub-region is not the mere trappings of democratic changes, but a change of mentality by leaders in particular and West Africans in general, consistent with constitutional rule and better appreciation of the rule of law in a modern state. The success of the governance protocols depends on the democratic credentials and actions of their subscribers. And on this matter, ECOWAS should not glorify itself with half-victories.
